

With its Sustainable Development Goals, the **2030 Agenda** for Sustainable Development is the first action plan to take all three dimensions of sustainability into account – economic, social and environmental aspects.

The German National Action Plan on Business and Human Rights (NAP) implements the UN Guiding Principles on Business and Human Rights (UNGPs) at the national level. It is relevant for German companies and their value and supply chains.

However, when it comes to occupational health and safety or environmental management, companies often find themselves challenged by human rights issues that require action.
